The undersigned State Prosecutor II of the Department of Justice, Manila, accuses Del Ayo Vera for Violation of Comelec resolution No. 8714 in relation to the Art 261 (q) of the Election Code committed as follows:

"That on or about February 6, 2010 at about 6:00 P.M. at Morong, Rizal, Philippines, and within the jurisdiction of this Honorable Court, the above name accused without the necessary permit to carry firearm from any government agency, did then and there, willfully, unlawfully and knowingly have in his possession and under his custody during the election period of the May 2010 elections a home made (paltik) cal. 38 with 4 live ammunitions.






