

"That on or about February 6, 2010, at about 6:00 P.M. at Morong, Rizal, Philippines, and within the jurisdiction of this Honorable Court, the above named accused, confederating, conspiring and mutually helping each other, with their knowledge, have in their possession and control improvised explosives, hand grenades, without any authority from any government agency, which intended to be made capable of producing destructive effect on contiguous objects and to cause injury or death to any person, to wit:

1. Three (3) pcs. hand grenade
2. One (1) canister 10412 improvised landmine
3. Five (5) pcs. Improvised claymore mines
4. Two (2) kg. Ammonium Nitrate
5. Thirty seven (37) pcs. improvised explosive sticks

The above articles were recovered from the above named accused by the searching police officers while they were having a teach-in or meeting in the place mentioned in the search warrant no. 1565-10, issued by the Regional Trial Court of Imus Cavite, signed by the Hon. Cesar A. Mangrobang.
